The Orme Academy has a well-regarded Learning Support team with a SENCo, who is a member of the Senior Leadership Team, and 7 experienced staff. We are all fully qualified and trained to meet the varied and changing needs of all students.

We aim to provide the most appropriate provision for any student who has Special Education Needs or disabilities and ensure that, where there is evidence that the pupil has significant needs, those needs will be made known to all who are likely to teach him or her. A co-ordinated and inclusive approach to support ensures that all of our students are cared for in an appropriate and personalised manner.

Our aims are;

- To help each student develop his/her potential to the full,
- To ensure that each student leaves school with the core skills of literacy, numeracy and social independence, which he/she will need in adult life,
- To help each student learn to appreciate and value his/her own strengths,
- To enable students to have the skills to take their place in society.

Our whole philosophy is based on flexibility of support, doing our utmost to create the best environment and facilities for students to be happy and successful. If something is possible – we will try it and if it seems impossible, we will look for a way to try to make it happen.

A wide range of support strategies are available for any student who has Special Educational Needs and/or Disabilities (SEND). Where there is evidence that a pupil has learning or emotional difficulties, we will support these students under the SEN Support Category as described by the SEND Code of Practice 2014. Students with an Education, Health and Care Plan (EHCP) will be supported to meet those specific objectives. The Orme Academy is an inclusive community and all students have access to all onsite provisions if required. [The SEND Policy](#) adheres to the Equalities Act 2010 and the SEND Code of Practice legislation introduced as part of The Children's and Families Act 2014. We welcome all students regardless of their special educational needs or disabilities, keeping them safe and well is also a priority, guided by our [Safeguarding and Child Protection Policy](#) which adheres to Keeping Children Safe In Education (September 2020) Please also take a look at our [Equality Policy](#) for further details.

The Local Offer documents all Special Educational providers and provisions available in the area and beyond. This acts as a means of informing parents and young people of the choices available to meet their individual needs.
